

Carmen Plaza is currently Professor of Administrative Law (*Profesora Titular*) and Director of the *Instituto de Derecho Europeo e Integración Regional* of the Law School of the *Universidad Complutense de Madrid* (Spain).

She obtained a PhD degree in Law from the Complutense University of Madrid (Extraordinary PhD Award), and an LL.M. in European Community Law from the University of Essex (United Kingdom). She was a Visiting Researcher at Harvard Law School in 1995 and carried out a stage at the Legal Service of the European Commission (Brussels) in 1996.

Prof. Plaza has collaborated in several national and European research projects in the areas of European Union law, environmental law, climate change, and competition law. She has also attended working meetings in the realm of environmental protection, human rights, and gender equality convened by EU institutions (such as the Council of the European Union or the European Parliament) and international organizations (such as the OECD and the United Nations). She has delivered courses and lectures on European Union Law, Environmental Law and Policy, and Equal Opportunities Law and Policy at various Universities in Europe and Latin America.

From May 2015 to October 2022, she was Legal Counsel of the Spanish Constitutional Court, and from January 2012 to April 2015 she was General Director for Equal Opportunities and Director of the Women's Institute (Ministry of Health, Social Affairs and Equality). She has likewise collaborated with legal foundations and law firms at different stages of her career.
